2-YEAR LIMITED WARRANTY**

Important notice regarding your consumer rights:

- The benefits we give in this manufacturer's warranty are additional to any rights and remedies that you may have under local consumer protection laws or under another contract. Nothing in this limited warranty limits or affects your legal rights.
- This limited Warranty is not intended to:
  - change or exclude any rights under consumer law that cannot be lawfully changed or excluded; or
  - limit or exclude any right you have against the person who sold the products to you if that person has breached their sales contract with you.

In particular, as a consumer, you legally benefit from a **minimum two-year statutory warranty of conformity** from the seller as set out in local legislation governing the sale of consumer goods.

Fender warrants that the Fender Bluetooth Speaker you have purchased shall be free of any defects in parts and workmanship if used under normal operating conditions for a period of two (2) years from the date of purchase or initial lease, except that cables and all other included accessory products are warranted for a period of ninety (90) days from date of purchase or initial lease ("Limited Warranty"). This Limited Warranty applies only to the original retail purchaser or lessee when purchased or leased from an Authorized Fender Dealer and is subject to the limitations set forth herein. **IMPORTANT: PLEASE RETAIN YOUR ORIGINAL SALES RECEIPT OR LEASE AGREEMENT, AS IT IS YOUR PROOF OF PURCHASE VALIDATING THIS LIMITED WARRANTY.**

**MAKING A CLAIM UNDER THIS WARRANTY:**

The Fender Dealer from whom you purchased your Fender Bluetooth Speaker should be the first point of contact when service of any kind is required for your Fender Bluetooth Speaker product. To receive warranty service, return the complete product to the Fender Dealer from whom you purchased your Fender Bluetooth Speaker, with your sales receipt as proof of purchase, during the applicable Limited Warranty period. To the extent feasible, defective components that qualify for coverage under this Limited Warranty may be repaired or replaced at Fender's discretion without charge. If the qualified component is not repaired, Fender may, at its sole discretion, either replace with a comparable product or refund the purchase price. Remedies beyond normal service repair of any Fender Bluetooth Speaker product require both an evaluation and confirmation of the defect and a direct recommendation to Fender from an Authorized Fender Dealer for alternative considerations.
