Important notice regarding your consumer rights:

- The benefits we give in this manufacturer's warranty are additional to any rights and remedies that you may have under local consumer protection laws or under another contract. Nothing in this limited warranty limits or affects your legal rights.
- This limited Warranty is not intended to:
  - change or exclude any rights under consumer law that cannot be lawfully changed or excluded; or
  - limit or exclude any right you have against the person who sold the products to you if that person has breached their sales contract with you.
- In particular, as a consumer, you legally benefit from a **minimum two-year statutory warranty of conformity** from the seller as set out in local legislation governing the sale of consumer goods.

Fender Musical Instruments Corporation (“FMIC”) warrants that the FMIC part or accessory you have purchased direct, shall be free of any defects in performance and workmanship if used under normal operating conditions for a period of two (2) years from the date of purchase, except that light bulbs, meters and rechargeable batteries are warranted for a period of ninety (90) days from the date of purchase and non-rechargeable batteries are not covered by this limited warranty.

This warranty shall apply only to the original purchaser. PLEASE RETAIN YOUR ORIGINAL INVOICE, AS IT IS YOUR PROOF OF PURCHASE COVERING YOUR LIMITED WARRANTY. THIS WARRANTY IS VOID WITHOUT SUCH PROOF OF PURCHASE.

At FMIC's discretion, defective parts or accessories will be replaced without charge with a like or comparable product, or the full purchase price will be refunded. Any repair or service performed on the product by any person or entity other than FMIC is not covered by this limited warranty.
